Bye-Laws for Housing Society | Apartment Complex - A Sample

If the Bye-law states that there can be a Non-Occupation-Charge (NOC), for a flat where Owner is not residing, then yes, the Tenant needs to pay the additional NOC Charge. As per Maharashtra Housing Society Law, the NOC charge is 10% of the Maintenance Charge. Outside Maharashtra, Associations typically set a flat rate for NOC.

Apartment Owners Association Registration in Bangalore 10Day

It is governed by the Transfer of Property Act,1882. You Should To Know about Karnataka Apartment Ownership Act (KAOA) of 1972. Before the property can be legally handed over to the owners, the builder has to register the Society within four months of sale of 60 per cent of the flats. Minimum seven or more members who must be above 18 years.
